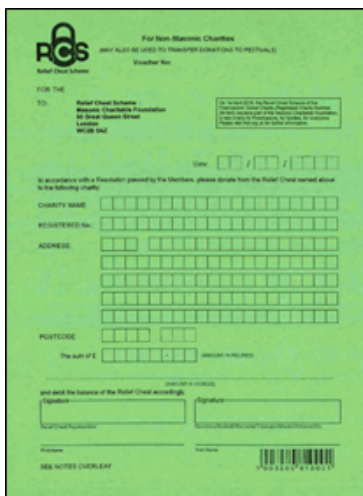


Transferring funds to the Festival Relief Chest from a Lodge/Chapter Relief Chest

Funds held in a Relief Chest **can be transferred to a Festival Relief Chest**. Transfer can be made using a Green form or e-voucher. The transfer amount can be allocated to the individual members for honorific purposes. Only complete a Transfer Allocation form if the donation amount is to be allocated to members.

Green Form

- Write **Gloucestershire 2029 Festival** as the charity name
- Write **GLOS2029** as the registered charity number
- add amount in numbers and words
- sign the form (Relief Chest representative + another officer)
- post the green form to Relief Chest Scheme
- enclose a transfer allocation form if applicable



e-Voucher

- Click on Request a Payment
- Register (your name and email address)
- Confirm registration (via email)
- start new voucher
- add payment details
 - Name:** Gloucestershire 2029
 - Festival Relief Chest Number:** GLOS2029
 - Amount:** £0.00
- add second signatory details
- submit the voucher

If the donation to be allocated to individuals for honorific purposes, complete the transfer allocation form separately and return to the Relief Chest Scheme.

E-voucher service

our E-voucher service allows Relief Chest holders to request payments to charities online.

Request a payment in three easy steps

1. Find your Relief Chest
2. Choose your charity and donation amount
3. Confirm and approve

Please note, as per the rules of the scheme, green forms are only issued to the listed Relief Chest representative of the Lodge/Chapter Relief Chest. If you require a supply of Green forms please contact the Relief Chest Scheme office. Similarly, to register for the e-voucher service, you must be the listed Relief Chest representative.

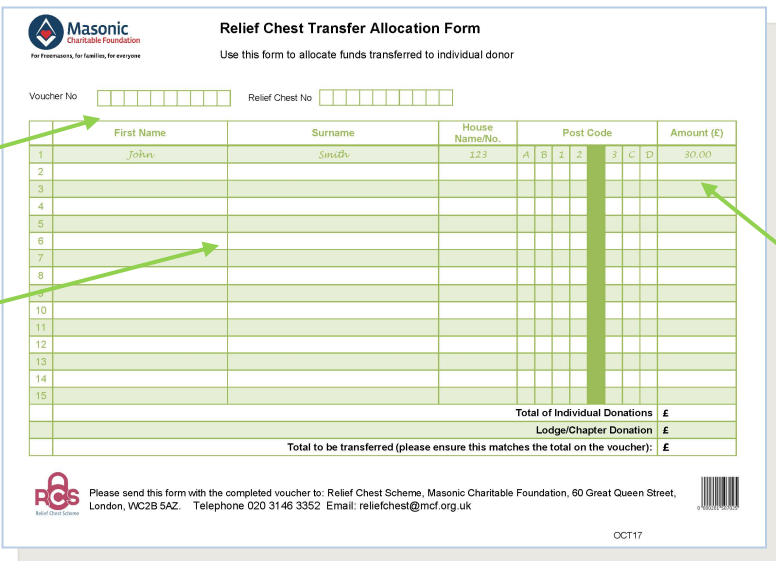
Completing a Relief Chest Transfer Allocation Form

The Relief Chest Transfer Allocation form is to be used with a Green Voucher when transferring funds from a Lodge/Chapter Relief Chest to a Festival Relief Chest if the funds are to be allocated to individuals for honorific purposes.

Write the corresponding Voucher number.

Complete the full name, house number and post code of each member to be allocated.

Remember to fill in how much each member is to be credited.

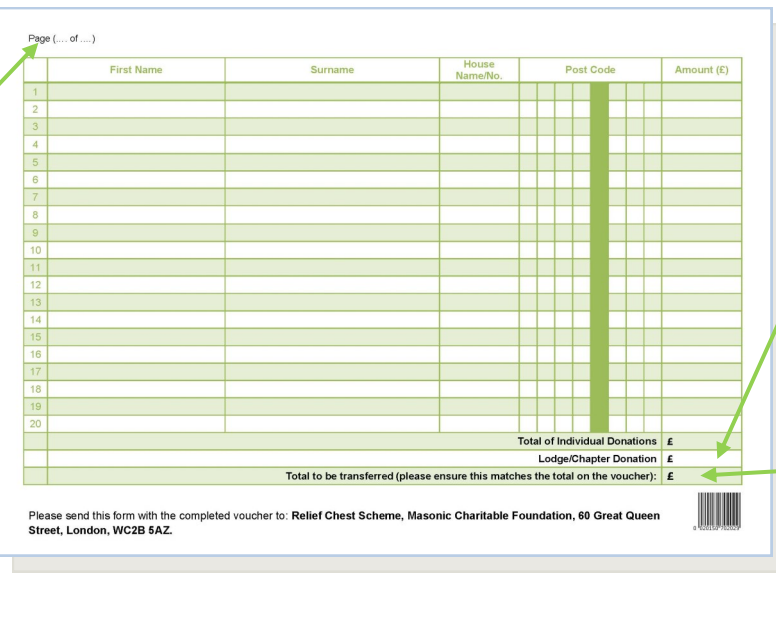
